THE ISSUE

SECONDHAND SMOKE

With over 7,000 chemicals in secondhand smoke, there is no safe level of exposure to secondhand smoke.

Secondhand smoke can cause:

- Heart disease
- Stroke
- Lung Cancer

THE ENVIRONMENT

Cigarette butts...

- are the MOST littered item in the world
- leach toxic chemicals into the land and water
- are a choking hazard for animals
- are NOT biodegradable

FREQUENTLY ASKED QUESTIONS

Q: Do we have the authority to enact polices restricting tobacco use outdoors?

A: Absolutely! Local government has the right to enact laws and policies to protect the citizens of their community.

Q: Isn't this an unnecessary policy?

A: No! It is essential to enact policies that protect the health and safety of all citizens. A tobacco-free policy is similar to a noise ordinance, leash law or litter law. These all protect citizens from harmful behaviors.

Q: How do we enforce this policy?

A: The majority of the population adheres to rules and regulations within their community. The success of the policy is a joint effort between the County and the Public to encourage compliance.
